II. Description of Test

Type/Purpose of Test: A questionnaire developed to measure a client's perceived manual ability. The questionnaire is given in an interview format.

Population: Originally developed for clients with rheumatoid arthritis, chronic stroke, or systematic sclerosis. For adults with upper limb impairments ages 16-80.

III. Practical Administration

Ease of Administration: Very easy to administer. The therapist only has to ask the client to estimate their perceived ease or difficulty of performing each task on the questionnaire, which are presented in random order and evaluated on a three level scale. Test packages of 10 score sheets and response scales for each form can be downloaded on the website for free.

Clarity of Directions: Administration directions are very clear. However there are a few caveats in the directions: not scoring items not completed in the last three months and reminding the client to give responses only when activities are done without help, irrespective of the limb(s) the client actually uses and whatever the strategies used to perform the activity that need to be explained to client. Interpret the online analysis is slightly more complicated, but useful once understood.

Scoring Procedures: Client's are asked to estimate their ease or difficulty in performing each activity when done without help, irrespective of the limb(s) the client actually uses and whatever the strategies used to perform the activity. The activity needs to be based on an experience within the last three months. If activity has not been attempted in past three months are marked as "?" on the response sheet, meaning not applicable. The form for clients with chronic stroke has 23 bimanual activities, the form for clients with rheumatoid arthritis has 27 bimanual activities, and the form for clients with systemic sclerosis has 26 uni- and bimanual activities. Clients rate each activity on a 3-level scale of impossible, difficult or easy. Responses from questionnaire can be submitted online for analysis on their website. The analysis converts raw scores into a linear measure. The vertical red line is the client's manual ability and the dotted red line is its 95% confidence interval, which is expressed in logits (a linear unit that expresses the odds of success of the patient on any given item). Clients with higher ability are denoted the further right they go. The item map on the analysis expresses which activities are the easiest and most difficult, which can be used in treatment planning and follow-up. Scores circled in red on the analysis can help identify atypical behavior or other comorbidities.

Examiner Qualification & Training: No training is required, anyone can read the website and download the assessment for free.
